Indonesian Capital Market Donated Ambulance to Support the Quality of Public Health Services in West Sumatra

1 September 2023

**Padang** - The Self-Regulatory Organizations (SRO), consisting of the Indonesia Stock Exchange (IDX), the Indonesian Clearing and Guarantee Corporation (IDClear), and the Indonesian Central Securities Depository (KSEI), held a corporate social responsibility (CSR) event within the framework of the Anniversary of 45 Years of Reactivation of the Indonesian Capital Market ("45th Anniversary of the Indonesian Capital Market"). At this event, the SROs delivered an ambulance and the associated medical equipment to support public health services provision in Solok Regency, West Sumatra, on Friday (1/9).

The ambulance and supporting medical equipment are urgently needed by the Jua Gaek Health Center, because currently the services from the health center are still below par. For example, should an emergency occur involving a patient who needed to be referred to a hospital, the Jua Gaek Health Center would still use the Health Center operational vehicle to take the patient to the hospital.

The Director of IDX, Risa E. Rustam, also a representative of the Indonesian capital market, symbolically handed over the assistance in the form of an ambulance unit and its supporting medical equipment to the Regional Secretary of Solok Medison Regency. Also present at the ceremony were Rahmad Hidayah, Head of Capital Market Supervision Subdivision of the West Sumatra branch of the Financial Services Authority (OJK), the President Director of IDClear, Iding Pardi, Head of the Solok District Health Office, Zulhendri, Chair of the Indonesian Doctors Association (IDI) of Solok Regency, Olo Prianti, and Head of the Jua Gaek Health Center, Silvia Febrina.

Iding Pardi in his remarks said, "This assistance shows the real action from the Indonesian capital market that demonstrates its concern for health services whose benefits can be directly felt by the community. The ambulance that we are donating is expected to improve the quality of public health services provided by the Jua Gaek Health Center, especially in handling emergency cases and referrals, so that they can be handled more quickly and more efficiently. This is also in light of the location of the health center, being in the area of the Trans-Sumatra highway, where roadside accidents, both serious and minor ones, tend to occur. We hope that the ambulance assistance and complete set of medical equipment can also improve the quality of health services, so that they get more evenly distributed in the remote areas of Solok Regency."

Epyardi Asda welcomed the assistance in the form of an ambulance from the capital market for the Jua Gaek Health Center. "We are very grateful for the provision of ambulance assistance from the Indonesian capital market. We need to say that currently the Jua Gaek Health Center has an ambulance which also functions as an operational vehicle, thus it may pose an obstacle in handling emergency medical cases that require an ambulance according to the standards. Of course, this ambulance will be very beneficial for the community and health workers at the Jua Gaek Health Center in carrying out emergency management and medical referral for the Solok Regency area."

Funds for the CSR activities held in commemoration of the 45th anniversary of the Indonesian Capital Market were obtained from an allocation of exchange transaction fees and central custodian service fees on 9 August 2022 and 29 December 2022. The funds amounted to Rp20.2 billion. Additionally, there was also the allocation of CSR funds from the implementation of the Indonesian Capital Market anniversary from the previous year, amounting to Rp12.20 billion. These funds have been subsequently used to implement CSR activities across many regions throughout Indonesia. The forms of CSR activities that have taken place include planting of trees, procurement of school boats, healthy children programs - stunting prevention, restoration of coastal areas including community capacity building, local food conservation, waste processing empowerment programs, processing of and campaigning against plastic waste, blood donations, ambulance assistance, supporting medical equipment and health facilities provision, as well as school renovations.

These various CSR activities are a form of appreciation for the achievements of the Indonesian capital market, as well as a form of commitment of the capital market to providing direct benefits to the community, particularly benefits that are related to the environmental, health, educational, social, and economic sectors. Furthermore, the SROs will regularly endeavour to conduct other CSR activities that deliver long-term benefits for the beneficiaries. This is in line with the government's efforts to attain the UN Sustainable Development Goals (SDGs), which are also a priority of national development.
